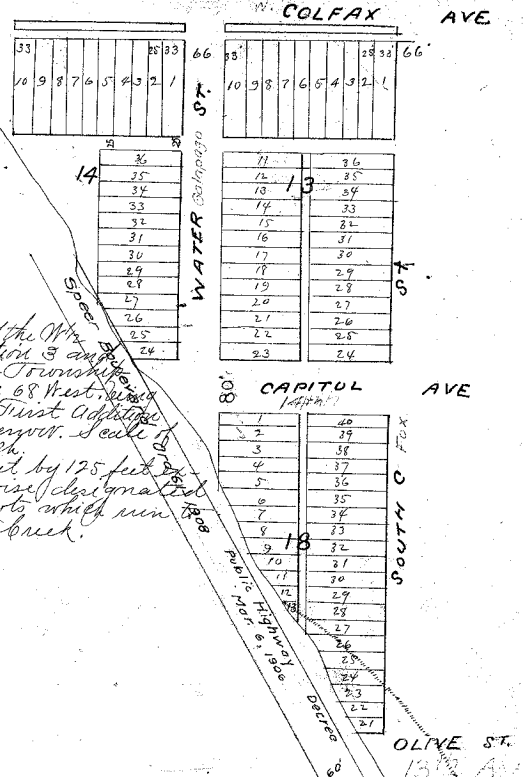
All lots 25 feet by 125 feet except where otherwise designated
